WHEREAS an Agreed Order (hereinafter "Agreed Order") dated June 28,
2007 entered in the United States Bankruptcy Court for the Middle District of Tennessee
in the matter known as In re: American Historic Racing Motorcycle Association, Ltd.
(BK No. 06-06626-MH3-11), provided that the Plaintiffs' claims against American
Historic Racing Motorcycle Association, Ltd., named herein as defendant A.H.R.M.A.,
Ltd. ("AHRMA"), insofar as they existed prior to the filing of a bankruptcy petition by
AHRMA on November 10, 2006, and AHRMA's counterclaims against Plaintiff's
asserted in this action would not be pursued.

IT IS HEREBY STIPULATED AND AGREED pursuant to F.R.Civ P.
41(a)(1) between and among the undersigned parties representing all of the parties who
have appeared in this action as follows:


- a) Plaintiffs' claims against AHRMA are hereby dismissed with prejudice.
- b) AHRMA's counterclaims against Plaintiffs are hereby dismissed with prejudice.
- c) Each party shall pay its own attorney fees and costs incurred with respect to this action.
- d) This stipulation does not release, limit or affect in any way any claim which any plaintiff may have against AHRMA for actions or omissions occurring or continuing on or after November 10, 2006.


