

On October 9, 2017, AHRMA's Board of Trustees made final decisions on rules proposals for the 2018 racing season. A summary of the proposals is below, with the final Board decisions displayed in orange type. The green type is record of the preliminary decisions rendered in July, prior to member feedback.

The votes recorded below are votes for/against a Trustee's <u>motion</u>; if the motion was to <u>reject</u> the proposal, a "<u>For</u>" vote is a vote <u>against</u> the proposal. Underlined wording would be new for the 2018 Handbook, a strike-through indicates wording proposed to be removed.

#### 3.3.14 & 14.1.e - Technical Inspection

Require that roadrace and dirt track helmets meet Snell 2015 standard (or equivalent) for the 2019 season. (Cindy Cowell)
