A fantastic event, in a wonderfully secluded place. Day one is a regular trials event. Day two is a Scott trial, a time-and-observation event.

A Support Class for trials bikes 1980 and newer will be offered. One Weekend membership (\$35) required for all Support Classes. No electric bikes, please.

Concessions: The Saturday afternoon BBQ and potluck are back! The BBQ meat will be provided by Redwood Engineering. The cost will be \$5.00 per person (volunteers eat free!). Please bring a side dish for the potluck if you are able to and have the means to do so. Donations of more than \$5.00 will be happily accepted!

Please note that there will be NO French Toast breakfast on Sunday morning.

Camping: Yes, but sorry, no trailers or motorhomes. You will not fit. Friday evening arrivals welcome. We recommend you come before dark.

This is a delightful area to come for a mini vacation.

Lodging recommendations: For those wishing to stay in town, please try the following:

Wildflower Boutique Motel in downtown Point Arena, right next door to Zen House Motorcycles. Look them up online or call (707) 207-6665

Wharf Masters Inn at the Point Arena Cove. Look them up online or call (707) 882-3171

There are also accommodations in Gualala, which is about 10 miles to the south of our property.

Directions: Located on private land.

From the SOUTH:

- Take Hwy 101 north to Santa Rosa
- Take River Road exit and go west through Guerneville and all the way to Hwy 1
- At Hwy 1, turn right and go through Jenner
- Stay on Hwy 1 through Gualala and Anchor Bay and proceed north approximately 7 miles.
- Begin looking for a concrete bridge, after which you will make an immediate right turn onto Schooner Gulch Road (it is a gravel road but a very good one). There is a street sign.
- Proceed up Schooner Gulch Road approximately 1.7 miles until you see a gravel road (not a
 driveway) to the left. There will be a long colored tape hanging from a redwood tree branch to
 indicate the turn. YOU WILL SEE A SIGN THAT READS: PRIVATE ROAD, OWNER ACCESS ONLY.
 This does not apply to our driveway, into which you will veer to the left.
- Once you make the left turn off Schooner Gulch Road, STAY LEFT and through the gateway which will have an orange delineator on both sides of the entrance, and an address sign with number 95100. Continue forward a short distance until you see someone to direct you for parking.

PLEASE, NO PARKING ON SCHOONER GULCH ROAD. COME INTO THE PROPERTY TO PARK – NO EXCEPTIONS.

From the NORTH:

- From Hwy 101 at Ukiah, take Hwy 253 west towards Booneville
- At Booneville, take Hwy 128. YOU WILL SEE A SIGN OFF OF 128 THAT DIRECTS YOU TO POINT ARENA. THIS IS A SHORTER WAY BUT A TERRIBLE ROAD. (SOME PEOPLE TOOK IT TO GET TO OUR STORNETTA EVENT IN 2011 AND WERE VERY SORRY)
- We advise not taking this road, but continuing on Hwy 128 all the way to the coast and Hwy 1
- At Hwy 1 turn left (south) and proceed to and through the town of Point Arena.
- After the Point Arena city limits, proceed approximately 3 miles to Schooner Gulch Road. Schooner Gulch Road sneaks up on you just after the top of a rise in the road; it is a left turn. If you cross over a concrete bridge on Hwy 1 you have passed it.
- Proceed up Schooner Gulch Road approximately 1.7 miles until you see a gravel road (not a driveway) to the left. There will be a long colored tape hanging from a redwood tree branch to indicate the turn. YOU WILL SEE A SIGN THAT READS: PRIVATE ROAD, OWNER ACCESS ONLY. This does not apply to our driveway, into which you will veer to the left.
- Once you make the left turn off Schooner Gulch Road, STAY LEFT and through the gateway which will have an orange delineator on both sides of the entrance, and an address sign with number 95100. Continue forward a short distance until you see someone to direct you for parking.

PLEASE, NO PARKING ON SCHOONER GULCH ROAD. COME INTO THE PROPERTY TO PARK – NO EXCEPTIONS.
